MEMORANDUM OF UNDERSTANDING

BASED ON THE AFORESAID, BOTH THE PARTIES HAVE ENTERED INTO THIS AGREEMENT ON THE FOLLOWING TERMS AND CONDITIONS MENTIONED BELOW:

Key Features:

- To organize various Research & Development and Training programs based on latest and emerging technologies for Students, Faculties, Law-Enforcement Agencies, Corporate Professionals, and Research Scholars etc.
- To organize National/ International Conferences.
- To organize FDP's, Seminars, Workshops, Guest Lectures, and Webinars etc.
- · To implement various Research and Development projects for the benefit of society.
- Will take care for the Projects and Case Studies related to Cyber Crime Investigation or Cyber Security
- More Interactions with Corporate, Law-Enforcement Agencies, Govt. organizations, Academics, etc.
- Implementation of Cyber Security Policies, Audits, Servers, Infrastructure, Industrial Visits, Live Projects, etc.

Responsibilities of SEDULITY:

- · Will act as a bridge between industry and academia.
- Will provide Sedulity Operating System and other open source software's required for the lab set-up.
- Will provide Professional and experienced trainers for the training purpose.
- Will provide Professional and experienced manpower to take care of the operational process.
- Will take care for the Projects and Case Studies related to Cyber Crime Investigation or Cyber Security.

Responsibilities of DAVIET:

- Will provide a furnished Internet lab of at least 30 computers (in beginning), a dedicated cabin with 200-300 Sq. Ft., along with Furniture and Fixing, Electricity and other basic Amenities.
- Will provide the Lab Assistant, Guard, Peon/ Office Boy, Cleaner etc. for the smooth operational process.
- To provide dedicated space for placing the Light Boards, Hoarding/ Flex in the campus and Lab Area.
- · 'Sedulity Solutions & Technologies' will be acknowledged as Technology partner.
- To provide Auditorium/ Seminar Hall for the Seminar/ Conference Purpose with all the facilities required like LCD Projector, Table Mike, Cordless Mike, Screen, Surround Sound Speaker System, and sitting arrangement for DIAS etc. (As & when required as per the dates provided in advance).
- To promote and Market the activities carried out by this MOU through various modes of Advertisement.
- In case, if any other requirement which appears to be important; that is not mentioned in this
 agreement, should also be provided by 'DAVIET' for the smooth Training and other research
 process.
- · Provide Proprietary / Commercial software's if required in case of any specific requirement.

Payment/ Commercial Ratio Terms:

- For initial Set-up, MOU signing amount (Non-Refundable) of Rs. 1,00,000 plus 14.5% service taxes extra, has been given by DAVIET via Cheque No. 822878, Dated: 10/12/2015, via Punjab National Bank in the favor of "SEDULITY SOLUTIONS & TECHNOLOGIES", Payable at New Delhi.
- Commercials will be mutually decided on project-to-project basis.
- The Training Fees charged by every student, faculty, or industry professional, will be decided
 as per the mutual understanding before the commencement of any training program.
- The Financials will be shared in advance before the commencement of the training or any
 project and therefore the Study Material or the Services will be distributed as per the strength
 of the participants.

- The payment should be made via Cheque payable at par/ DD payable at New Delhi, in the favor of "SEDULITY SOLUTIONS & TECHNOLOGIES".
- There will be an additional service tax applicable on the total payable amount. Currently the service tax ratio is 14.5% which may vary as per the Govt. norms in future.
- All Govt. Taxes will be applicable in future as per the ratio prescribed by Govt. of India.

Terms, Changes, and Termination

Terms:

This MOU will be effective from the "Date" it is Duly Signed by "SEDULITY and DAVIET". The duration of this agreement is 5 years from the date it is signed. All the operations will be taken care by Mr. Mukul, Vice President – Sedulity and Dr. Vinay Chopra, Assistant Prof. – DAVIET.

This MOU is an exclusive agreement of "Centre of Excellence" where SEDULITY and DAVIET hereby agreed that no more Centre of Excellence will be opened in entire Jalandhar by Sedulity and DAVIET will not entertain any other organization for conducting any Training, Research work or project related to Cyber Security.

Changes:

At any time after providing notice, Sedulity in its sole discretion may:

- · Add any new Product, Service, Solutions etc. Or
- Cancel any or all Products, Services, Solutions etc. Or
- · Change, Modify, or Discontinue part or all of the Products, Services, Solutions etc. Or
- Change, Modify, or Discontinue any Commercial ratio or any other term related to this
 contract.

Termination:

Any party may voluntarily terminate this agreement at any time by giving a notice in writing with the period of 6 months or the completion of any commitment/ Services/ Projects whichever comes earlier.

No Damages

In no event shall Sedulity Solutions & Technologies or any of it's parent or sister concern, employee, clients, suppliers have any liability to DAVIET for damages of any nature whatsoever, (direct, indirect, special or consequential) including without limitation, any Hardware, lost profits, loss of data, interruption of business, or costs of procurement of substitute goods or services, whether under theory of contract, even if Sedulity is advised of the possibility of such damages.

This Agreement shall be governed by and construed in accordance with the laws of India.
