

# Sexual Harassment & Redressal Committee

#### Sexual Harassment Redressal Committee

The Women's Cell of DAVIET looks after the welfare of female employees and girl students of the institute. It facilitates redressal of their problems and caters to their issues/ grievances. The cell promotes all round development of female employees and girl students of the Institute to enhance their self-esteem and self-confidence.

The Internal Complaint Committee has been framed as "Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013" w.e.f March 3<sup>rd</sup>, 2017 with office circular issued by the Principal, DAVIET. Its objective is to provide its female employees and girl students an environment free from harassment/discrimination and ensure that they are treated with dignity and respect. The Committee shall investigate the reported cases of commission of acts of sexual harassment of women, if any, and submit its report to the disciplinary authority with the recommendatory action to be taken against the accused.

Internal Policy for Prevention, Prohibition and Redressal of Sexual Harassment of Women at Workplace is in place. This Policy applies to all women associated with DAVIET including permanent employees, temporary employees as well as employees on contract, research scholars, students and trainees (if any).

The institute has setup Crèche for providing childcare facility for the staff. The Women's Cell also looks after the management of the Creche in the Institute and prescribes necessary guidelines for its smooth functioning.

#### **Internal Complaint Committee Policy**

#### Who can approach Internal Complaint Committee for help?

Any woman employee academic/ non-academic (including contractual, casual and temporary) and female students of DAVIET, Jalandhar can approach the Cell.

#### **Definition of Sexual Harassment:**

"Sexual harassment" includes such unwelcome sexually determined behavior, whether directly or otherwise, as:

- physical contact and advances
- demand or request for sexual favors
- sexually colored remarks
- showing any pornography, or
- any other unwelcome physical, verbal or non-verbal conduct of a sexual nature

#### What are the possible actions that can be taken against the culprit?

- Warning
- Adverse remark in the service record/personal file
- Withholding of annual routine increments/promotion
- Suspension
- Dismissal

#### If you are harassed, what should you do?

- The complainant will have to submit a written and signed two copies of the complaint along with supporting documents to the Women Cell.
- You can also reach the Internal Complaint Committee at womencell@davietjal.org

Rest assured that your complaint will be kept **CONFIDENTIAL**.

#### **Inquiry process:**

- The inquiry shall be completed within a period of ninety days from the date of the complaint.
- On completion of the inquiry, the Internal Committee shall provide a report of its
  findings to the institute administration within a period of ten days from the date of
  completion of the inquiry and such report will be made available to the concerned
  parties.
- If the allegations against the respondent have been proved, it shall recommend punitive actions to be taken against the respondent to the institute administration.
- The institute administration shall act upon the recommendation within sixty days of its receipt.



#### 4. Procedure for Redressal of Grievance

An aggrieved student shall first submit his complaint in writing to his/her mentor who shall resolve the grievance with 02 days. In case the mentor is not able to resolve the grievance, she/he shall forward it to the chairperson of the Grievance Redressal Committee.

The chairperson of Committee shall convene a meeting of the committee within 02 days of receiving the complaint from the faculty mentor or from the aggrieved student in case he/she applies directly to the committee. The chairperson shall attempt to resolve the grievance within a week of the receipt of the complaint.

If the student is not satisfied with the solution of the committee, he/she shall appeal to the worthy Principal giving the reasons for his/her dissatisfaction with the decision within a week of receipt of the decision.

The worthy Principal shall convene a meeting of the committee with 02 days of receiving the complaint. The Principal shall review the decision and pass an appropriate order. The Principal, if needed may recommend necessary corrective action to ensure avoidance of recurrence of similar grievance in the Institute.
